# Citius Tech Sustainable Procurement Policy



## **Purpose**

#### **Definition**

Sustainable procurement is the practice of purchasing goods and services that have a reduced environmental and social impact throughout their life cycle, while also maximizing economic value. Sustainable procurement considers the entire supply chain from production to disposal. It is a key tool for achieving sustainable development goals and reducing the impact of business activities on the environment and society.

#### Commitment

The policy encompasses the commitment to the following objectives:

#### **Ethical and sustainable sourcing:**

- Prioritize suppliers who share our commitment to sustainability, environmental and social practices, and conduct regular due diligence & performance reviews of our suppliers.
- Prioritize suppliers who share our commitment to respecting the human rights of all individuals, including employees, and other stakeholders, providing safe working environment and fair employment practices.
- To promote sustainable procurement practices, such as purchasing products and services that are sustainably produced, energy-efficient, and environmentally friendly, and avoiding products that are harmful to the environment or produced under unethical conditions.

#### **Supply chain transparency:**

- Maintain transparency in our supply chain, communicating our sustainability expectations to our suppliers and working with them to improve their sustainability practices.
- Integrating, tracking & reporting sustainable procurement objectives & performance of suppliers as part of CitiusTech's overall performance reviews.



#### Waste reduction:

• Minimize waste in our procurement practices, promoting the use of recycled materials, minimizing packaging, and reducing the use of single-use products.

#### **Supplier / Vendor Diversity:**

 Provide equal opportunities to all suppliers/ vendors, including suppliers /vendors who are small, belonging to scheduled castes, or religious minority owned, women-owned, veteranowned, LGBTQ+ owned, and disabled-owned businesses and who meet the quality requirement and performance standards.

### **Supply chain Capacity Building:**

• Will endeavor to make suppliers aware of environmental & social issues.

#### **Continuous improvement:**

 Regularly review and update our procurement practices, incorporating feedback from our stakeholders including suppliers & their employees and adapting to evolving best practices and standards.
